Ladies and Gentlemen of Red Brush

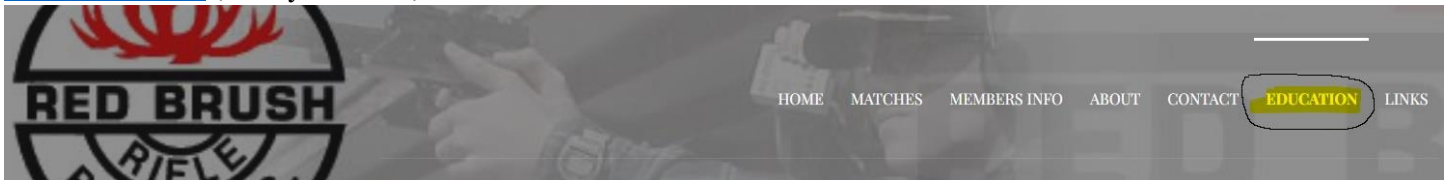

## **FROM THE RANGE OFFICER, FRANK FINDLEY**

### **Return Target Stands to Their Original Bays**

It is okay to move target stands from one bay to another when needed. But please remember to return them to their original bays. This includes any target stands used for leagues and events. It is disrespectful to force other members to have to hunt them down.

### **Do Not Shoot the Concrete Walls of Bays 6 Through 10**

We have had a report of a member shooting into the concrete walls of bay 6 through 10. This is both dangerous and damaging. These walls, in fact all side berms, are not to be shot directly. Their purpose is to protect against ricochets and splatter entering other bays.

In these bays you can shoot at multiple targets at angles. But the targets must be placed so that the bullets will impact directly into the back berm. Place all targets a minimum of six feet from a concrete, side wall when near the impact berm. If the target is placed closer to the firing line, make sure the target is placed so that a bullet will not pass through it and strike the concrete side wall. Look for a red post beside the walls on each side. Keep your targets inside the area between these posts. Remember, you can always set up your targets directly in front of the back berm and set up an ad hoc firing line inside the bay. This will ensure the rounds impact directly into the back berm.

### **R7 Mako Safety Recall Issued by Kimber Manufacturing**

Kimber Manufacturing has issued a safety recall for their R7 Mako handgun. It applies to R7 models that were shipped between January 10th, 2022, and February 14th, 2022. A quality issue in the firing pin safety block can make the firearm fire multiple shots with a single activation of the trigger. ### **Personal Opinion: Constitutional Carry Will Make Indiana a Safer State**

An important change of law is happening which will make Indiana safer. On July 1, Indiana will join over twenty other states in recognizing people's constitutional right to carry a handgun. On that date, the law-abiding will be able to carry a handgun in Indiana without obtaining a license. However, if such a person desires an Indiana license to carry while traveling in other states with reciprocity, it is still available. There is no change regarding those who cannot legally own a firearm, they are still prohibited. And a background check is still required when purchasing a firearm from a dealer. It is worthwhile to look at how and why we got to this positive place.

Indiana's constitution explicitly says that "[t]he people shall have a right to bear arms, for the defense of themselves and the State". But an antiquated and questionable Indiana court decision held that handguns were unusual arms in that they were "readily concealed" and therefore could be more heavily regulated than (at the time) the more common rifles and shotguns. This created the unusual situation where an adult in Indiana could carry a rifle openly in public, but carrying a handgun was prohibited without law enforcement permission. And this permission from the local chief law enforcement officer wasn't always forthcoming despite the individual being a law-abiding citizen.

Gun rights organizations like the NRA made it a priority to roll back this prohibition and through their efforts the restrictions have gradually loosened over time. Changes over the last few decades include a movement from 'may issue' to 'shall issue', change from regular renewals to lifetime licenses, elimination of the requirement of a target shooting license to use ranges, reduction of license fees of hundreds of dollars to no-fee, and those with protective orders being allowed to carry while their carry license applications were in process.

Each of these changes met with resistance from anti-gun groups and, occasionally, small numbers in the law enforcement community. Their most common refrain was that “there will be blood on the streets” if the proposed change was implemented. In all cases, this proved false. In fact, these changes were regularly followed by drops in crime. People came to realize that criminals do not follow the handgun licensing laws, it is only the law-abiding who do. Therefore, the end result of the loosening of restrictions was that there were more “good guys (and gals!) with guns” to stop the “bad guys with guns.”

Despite these liberalizations, there were still terrible problems with the partially reformed licensing system. One was trusting sensitive personal information to third parties. The requirement that law-abiding citizens pay for fingerprinting and submit this with their license application was a deterrent to many people. In an age when biometrics are used to secure about everything and that databases held by government vendors are under constant threat of being hacked; it was seen as too much of a security risk. Exacerbating this, anti-gun groups have actively tried to get access to handgun license databases through public information requests. The purpose is to fuel their “cancel culture” campaigns. Imagine a constant barrage of phone calls to your employer to fire you because you are a “dangerous gun nut”. Going through the permit process was thus risky for less economically secure individuals.

But there were severe problems inherent in not obtaining the license. The law allowed those without licenses to transport firearms to ranges for training, but they had to be locked away and not readily accessible. For people who relied on walking, biking, and public transportation (like college students, the elderly, and the poor), this was a seemingly impossible requirement to meet. Even people with motorcycles and small vehicles faced the very real possibility that they also could be found in violation of the vaguely worded requirement. Thus, they simply would not get training and practice.

Another example were homeowners trying to escape rioters during the tumultuous lead-up to the 2020 elections. If they fled on foot with their firearms, they would be in violation of the law. But if they left the firearms in their home or vehicle, there was every possibility the rioters would steal the firearms. This worry was shown to be justified by the videos on social media showing rioters breaking into the trunks of burning police cars to retrieve the rifles stored there.

And while the law allowed those with a protective order to carry while waiting for a license, they could not carry while they waited for the court hearing to obtain the order. We simply do not know how many people were assaulted because they were denied the ability to protect themselves from stalkers and domestic abusers.

Public attention of shortfalls in the licensing system rose at the start of the Covid-19 pandemic. Millions of people purchased a firearm for the first time, with handguns being the most popular choice. And many of these new gunowners were shocked to learn how bureaucratic the process is; paperwork, background checks, carry licensing, etc. And to put an exclamation point on it, those who did apply for a carry license learned that the application processing had all but shut down. Their frustrations turned into a powerful movement to fix an obviously non-functioning system. At the heart was the simple point that “a right delayed is a right denied”. This was coupled with the realization that no other right was treated in this sort of manner. Imagine having to submit your fingerprints to vote!

This bolstered political efforts to complete the reform of Indiana’s handgun carry licensing system. Given recent U.S. Supreme Court decisions on the right to keep and bear arms being an individual right and that handguns were common and not unusual firearms, recognizing carrying handguns as a constitutional right was as obvious as  $1 + 1 = 2$ . And with twenty other states having already implemented constitutional carry with overwhelming positive experiences, there were no substantive points to be made against it. No state which has implemented constitutional carry has changed back. Given all the positive benefits; more freedom, more security, and less crime, why would they?

Thank you to all those who fought for years to make this happen.
