FROM THE RANGE OFFICER, FRANK FINDLEY

MAGAZINES MUST BE REMOVED FROM FIREARMS DURING CLEAR PERIODS AND FIREARMS MUST NOT BE HANDLED WHEN PEOPLE ARE DOWN RANGE

There were several reported incidents of violations of the safety rules in June. They all revolved around the condition and handling of firearms during the clear period on the 400-yard rifle bay. So, we are reminding members of a few points:

Magazines must be removed from firearms during CLEAR periods. The exact wording from the range rules is:

"Unloaded condition for the range means that all ammunition has been verified to be removed from the gun and the action is locked open (if locking open is practical). This includes <u>completely removing easily detachable</u> <u>magazines</u>. All rounds must be removed from fixed magazines and revolver cylinders. Black-powder firearms must have no ball or powder in chamber, and for percussion guns, the caps must be removed."

Do not handle firearms when people are down range. This includes adjusting scopes and bringing firearms to the line. This is a violation of Fundamental Rule of Gun Safety #1 and constitutes "muzzling" a person. This is a severe breach of safety.

Do not cross the firing line to set up equipment while the bay is in a HOT condition. Even if it is only a couple feet, it is extremely dangerous. If you see someone break the plane of the firing line with their body, please immediately use the CEASE FIRING line command to stop the shooting on the bay and have the person get back behind the line.

With summer we are having a lot of members come out to shoot who haven't done so for a while. Please help them "get the rust off" by alerting them if they are violating or it looks like they may be about to violate our safety protocols. And if someone points something out to you, please do not be defensive. They are only helping keep Red Brush remain "A Safe Place to Shoot".

REMINDER: NO EXPLOSIVES – INCLUDING FIREWORKS – ALLOWED ON THE RANGE

Please remember that no explosives are allowed on the range without explicit board approval. This includes fireworks and the use of exploding targets such as Tannerite®.

MEMBERSHIPS SUSPENDED FOR SHOOTING BOTTLENECK CARTRIDGES ON BAYS 1 & 2?

We are reincluding this information in our newsletter because there have recently been additional instances of bottleneck .223 cartridges being shot on Bays 1 and 2. Please be aware that the typical board-imposed penalty for this is <u>suspension of range privileges for 30 to 90 days</u>. In malicious instances, the board may even choose to expel the member.

One of the reasons for this level of penalty is the damage which has been done to steel targets and equipment placed on these bays. Stated simply, considerable damage has been done in the past and this has cost substantial money which otherwise could have been spent on range improvements. It is also a safety issue as holes and indentations on steel can send bullets in unpredictable directions including back at the shooter. Here is an example of such a damaged plate:


For those who are not familiar with this topic, here are some questions and answers:



What is a bottleneck cartridge? A bottleneck cartridge is one that has a shoulder that narrows down the case to create a small mouth (see below diagram). This allows for a similar amount of powder to be loaded as a similar sized straight wall cartridge but places it behind a smaller diameter, and therefore typically lighter, bullet. Because the bullet is lighter, it has a comparatively greater velocity when fired. It is this increased velocity which leads to the damage of steel plates.

Are rimfire and pistol caliber bottleneck cartridges included in this restriction? Yes, it is not just a restriction on rifle centerfire bottleneck cartridges. Pistol and rimfire bottleneck cartridges are also not allowed on these bays. Respective examples are the 22 TCM and 17 HMR.

Are there any exceptions to this rule? The board has approved the following bottleneck cartridges for use on pistol bays 1 & 2: .357 Sig, 30 Mauser and .44-40 Winchester. These are the only explicit exceptions.

BATFE PISTOL BRACE RULE CHANGE HAS MAJOR NEGATIVE IMPLICATIONS FOR DISABLED SHOOTERS AND POTENTIALLY ALL GUN OWNERS

Recently the Bureau of Alcohol, Tobacco, Firearms and Explosives (BATFE) has changed a longstanding rule on the legality of pistol braces. Since its invention in 2012, the pistol brace has been considered a perfectly legal accessory for large pistols that did not change the firearms status as a pistol. But as of June 1, the ATF has, without any law change by congress, declared that these devices convert pistols to NFA restricted short-barreled rifles (SBRs), with associated penalties of fines up to \$250,000 and 10 years in federal prison for possession.

This is a terrible hit for disabled shooters. The first pistol brace was invented by Alex Bosco to help disabled veterans shoot the popular AR-15 pistol more accurately and safely. This empowered them to participate in popular AR shooting activities. Without the stabilization afforded by pistol braces, these shooters cannot appropriately handle the firearms and therefore this change essentially constitutes a ban on their involvement in the shooting sports, hunting, and other second amendment protected activities. Gun rights organizations including, among others, the National Rifle Association, National Association for Gun Rights, Gun Owners of America, the Second Amendment Foundation, and the Firearms Policy Coalition, are working through congress and the courts to get this capricious and abusive rule change overturned. The majority of States, including Indiana and Kentucky, are also suing to protect the rights of their citizens. From their perspective, allowing the precedent of the BATFE to arbitrarily change rules puts all firearms and firearm accessories at risk of being restricted. Many argue this isn't a slippery slope but rather a steep cliff. Please consider supporting these efforts by letting your congressional representatives and senators know where you stand on this issue.

COPPERHEAD SNAKES SEEN AT RED BRUSH

Members have recently reported seeing copperhead snakes on the East side of our property near the lake. Copperhead snakes are one of the few indigenous venomous snakes in Indiana. They are rarely aggressive so will generally leave you alone if you leave them alone. But if they are startled (e.g., stepped on) they may bite defensively.
